## ASSOCIATESHIP FOR SHARAD PAWAR INDOOR CRICKET ACADEMY & RECREATION CENTRE AT BANDRA KURLA COMPLEX

Dear Members,

This is to inform all the **Permanent and Life Members** of Bombay Gymkhana that Mumbai Cricket Association (MCA) have allotted two Associateship of the MCA Sharad Pawar Indoor Cricket Academy and Recreation Centre-BKC, to each of its affiliated Member Clubs. Bombay Gymkhana being a Member of the MCA is eligible for Associateship for the Sharad Pawar Indoor Cricket Academy and Recreation Centre (BKC). The applications from the affiliated Clubs are required to be submitted to MCA on or before Friday 7<sup>th</sup> February 2025. The admission fee required to be paid for the membership would be Rs. 50,000/- plus G.S.T.@ 18% i.e. Rs. 59,000/-

The matter was discussed at the Managing Committee meeting held on 10<sup>th</sup> December 2024, and it was decided that the Associateship for the Sharad Pawar indoor Cricket Academy and Recreation Centre-BKC would be auctioned to **Permanent /Life Members** of the Gymkhana at a floor price of Rs.18,00,000/- plus GST @ 18%. i.e. Rs. 21,24,000/- and allotment would be made to the highest bidder. In case there are three or more bids which are of the same amount and are highest, then the eligible members will be decided by draw of lots.

All **Permanent/Life Members** of Bombay Gymkhana who wish to apply for Associateship of Sharad Pawar Indoor Cricket Academy and Recreation Centre are requested to kindly submit their bids in a sealed cover addressed to the Chief Operating Officer marked on the Envelope "**Bid for Associateship of the Sharad Pawar Indoor Cricket Academy & Recreation Centre**" on or before 5.00 p.m. on 15<sup>th</sup> January 2025. The bids will be opened the same day in the Dining Hall at 5.15 pm, in the presence of Mr. Burzin Dubash, Hon. Secretary – Cricket and the Members who have submitted their bids and any other Member who may wish to be present. Thereafter, the Gymkhana would announce the name of the Members who have submitted the highest bids for Associateship and he / she would be required to complete the application form immediately for submission to the Mumbai Cricket Association.

The bids should be accompanied with a cheque / DD for the full bid amount plus GST @18% as applicable, drawn in favour of "Bombay Gymkhana Ltd".

The encashment would only be done in respect of the Members who have bid the highest and become eligible for Associateship.

**Bids once submitted can be withdrawn till 3:00 pm on 15<sup>th</sup> January 2025. After that no request for withdrawal will be entertained.**


It is further clarified that the Member and their family, as per the rules of the Sharad Pawar Indoor Cricket Academy & Recreation Centre, would be able to utilize the facilities of the of the Sharad Pawar Indoor Cricket Academy & Recreation Centre & the Members whose names are finally nominated by the Gymkhana for Associateship shall not transfer/sell their membership & will be subject to rules & regulations as applicable to such membership.

Privileges of such a membership are given by MCA (Sharad Pawar Indoor Cricket Academy and Recreation Centre-BKC) are listed below:

- a) Members will be only till the life of the allotted member and returned to Bombay Gymkhana thereafter,
- b) Spouse member till the same date.
- c) Children can be dependent members – Boys till 21 years, Girls till 18 years of age.
- d) Dependent membership of children ceases beyond this age.
- e) No voting rights are offered to such member. (Associateship)
- f) This member is allowed to visit MCA- Sachin Tendulkar Club in Kandivali for 2 days on weekdays only.
- g) All charges are applicable as per club rules.

Members submitting the bids are also requested to contact the Sharad Pawar Indoor Cricket Academy & Recreation Centre to obtain full details in regard to their entitlements and annual subscription.
